

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Contract Services With Pima Community College
Skill Center)

RES. NO. 288-89

1 WHEREAS, the Job Training Partnership Act (P.L. 97-300) replaced
2 the Comprehensive Employment and Training Act (CETA) in
3 1982; and

4 WHEREAS, funding is made available to contract training services
5 to establish programs for improving the employment/
6 training prospects of eligible persons; and

7 WHEREAS, the Tohono O'odham Nation is entitled to JTPA funds to
8 develop a network of employment and training programs
9 throughout the Nation; and

10 WHEREAS, the Tohono O'odham Nation, JTPA Programs has been
11 designated to deliver employment and training services
12 to JTPA eligible individuals; and

13 WHEREAS, the Tohono O'odham Nation, JTPA Programs has provided
14 JTPA training services pursuant to contractual agree-
15 ments with the Pima Community College Skill Center
16 since the inception of JTPA; and

17 WHEREAS, the Tohono O'odham Nation, JTPA Programs desire to
18 contracts services with the (Pima Community College
19 Skill Center for PY 1989 (July 01, 1989 - June 30,
20 1990).

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
22 Council that it hereby approves the Contractual
23 Agreement between the Tohono O'odham Nation, JTPA
24 Programs and the Pima Community College Skill Center
25 for PY 1989 for the delivery of training services to the
26 Tohono O'odham Members.

27 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
28 that the Tohono O'odham Nation's Officials, to wit: The
29 Chairman, Vice Chairman and any designated official are
30 hereby authorized to negotiate and execute the grant,
31 provided, however, that any amendments affecting the
32 funding or funding levels of this grant shall be
submitted for further prior approval by this Council.
