- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby authorize and request the Bureau of Indian Affairs to extend Contract No. H50C14208057 with the Tohono O'odham Nation under P.L. 93-638 regulations and procedures for the provision of services titled: Credit and Finance.
- BE IT FURTHER RESOLVED that the duration of this contract extension will commence on October 01, 1989 through December 31, 1989.
- BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract extension has been approved by the Bureau of Indian Affairs.
- BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: The Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided, however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.
