1 WHEREAS, the Sells District Council has in their District Council  
2 \$353,434.62 plus to cover all the projected budget  
3 expenses for fiscal year 1990; and


4 WHEREAS, the proposed budget of the Sells District Council has  
5 been explained to this Legislative Body of the Tohono  
6 O'odham Nation for their consideration and approval; and

7 WHEREAS, under the Constitution of the Tohono O'odham Nation,  
8 Article VI - Powers of the Tohono O'odham Council,  
9 Section 1., (d) (3) to adopt, approval and amend annual  
10 budgets and to authorize the expenditure of funds in  
11 accordance with these budgets.


12 NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative  
13 Council to adopt the Sells District Council budget of  
14 \$115,463.00 for FY-1990.

15 The foregoing Resolution was passed by the Tohono O'odham Council  
16 on the 18th day of September, 1989 at a meeting at which a quorum  
17 was present with a vote of 1,724.0 for; 0 against; 0 not  
18 voting; 1 absent, pursuant to the powers vested in the Council  
19 by Section 1 (d) (3) of Article VI of the Constitution of the  
20 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
21 January 18, 1986, and approved by the Acting Deputy Assistant  
22 Secretary - Indian Affairs (Operations) on March 6, 1986,  
23 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
24 984).




