

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Baboquivari District FY '90 Budget)

RES. NO. 298-89

1 WHEREAS, the Baboquivari District Council has considered and  
2 reviewed its proposed activities for FY '90 and has  
3 prepared a budget to cover anticipated costs and  
4 expenses; and

5 WHEREAS, the Baboquivari District Council did adopt a proposed  
6 budget for FY '90 in the amount of \$362,551.64. Said  
7 Budget to begin on October 01, 1989 and end on September  
8 30, 1990; and

9 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the  
10 proposed budget and approves of same.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
12 Council that it hereby approves the Baboquivari District  
13 budget to be expended in accordance with the attached  
14 budget.

15 The foregoing Resolution was passed by the Tohono O'odham Council  
16 on the 18th. day of September, 1989 at a meeting at which a  
17 quorum was present with a vote of 1,724.0 for; -0- against; -0-  
18 not voting; and 01 absent, pursuant to the powers vested in the  
19 Council by Section 1 (d)(3) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






