(Override Veto of Res. No. 20-89 "Approval of Agreement
in Principle for Cost Sharing of Joint Use Facilities to
be designed and constructed as part of San Xavier New
Farm Development)

2 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution
3 No. 20-89 approve an Agreement in Principle for Cost
4 Sharing of Joint Use Facilities to be designed and
5 constructed as part of the San Xavier New Farm
6 Development; and

7 WHEREAS, upon presentation of Resolution No. 20-89 to the
8 Chairman of the Tohono O'Odham Nation he did disapprove
9 thereof and returning it to the Council with his
10 objections in accordance with the provisions of Article
11 VII, Section 5 of the Constitution of the Tohono O'Odham
12 Nation; and

13 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
14 Chairman's objections and after consideration again
15 voted to pass Resolution No. 20-89 .


16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
17 Legislative Council does hereby override the Chairman's
18 veto of Resolution No. 20-89 , by a vote of two-thirds
19 (2/3) of the votes cast 807.0

21 The foregoing resolution was presented to the Tohono O'Odham
22 Legislative Council on the 6th. day of February , 1989, at a
23 meeting at which a quorum was present and, by a vote of 1,084.0
24 for; 126.0 against; 272.0 not voting; and 158.0 absent, was
25 passed by a majority of at least two-thirds (2/3) of the votes
26 cast and became law as provided in Section 5 of Article VII of
27 the Constitution of the Tohono O'Odham Nation.


