The foregoing resolution was presented to the Tohono O'Odham Legislative Council on the 6th. day of February , 1989, at a meeting at which a quorum was present and, by a vote of 1,084.0 for; 126.0 against; 272.0 not voting; and 158.0 absent, was passed by a majority of at least two-thirds (2/3) of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
