The foregoing Resolution was passed by the Tohono O'odham Council 12 on the <u>18th</u> day of <u>September</u>, <u>1989</u> at a meeting at which a quorum was present with a vote of <u>1,724.0</u> for; <u>-0-</u> against; <u>-0-</u> 13 not voting; and <u>01</u> absent, pursuant to the powers vested in the Council by Section <u>1 (d)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation 14 on January 18, 1986, and approved by the Acting Deputy Assistant 15 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 16 17 TOHONO O'ODHAM LEGISLATIVE COUNCIL 18 19 Edward D.
