

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Extension of Appointment - Antone Chico, Jr.)

RES. NO. 302-89

1 WHEREAS, Article VIII of the Constitution of the Tohono O'Odham
2 Nation requires the Legislative Council to appoint
3 judges of the Tohono O'Odham Courts; and

4 WHEREAS, the Council by Resolution No. 106-89 on April 18, 1989
5 did appoint Antone Chico, Jr. as a judge of the Tohono
6 O'Odham Courts; and

7 WHEREAS, the Tohono O'Odham Legislative Council specified a term
8 of four (4) years for this appointment; and

9 WHEREAS, the Judiciary Committee of the Legislative Council has
10 reviewed appointments of judges; and

11 WHEREAS, the Constitution of the Tohono O'Odham Nation mandates
12 subsequent appointments of judges after the initial
13 appointments be for terms of six (6) years; and

14 WHEREAS, the Judiciary Committee recommends to the Council that
15 the term of Judge Antone Chico, Jr. should be extended
16 to be in compliance with the Constitution.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that it does hereby accept the recommendation of
19 the Judiciary Committee to extend the term of Antone
20 Chico, Jr. as a judge of the Tohono O'Odham Courts for
21 an additional two years beyond the four year appointment
22 approved by Legislative Council Resolution No. 106-89 on
23 April 18, 1989.

24 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
25 of the Tohono O'Odham Nation that the effective date of
26 Judge Chico's appointment for a subsequent six (6) year
27 term remain unchanged.

28 The foregoing Resolution was passed by the Tohono O'odham Council
29 on the 18th. day of September, 1989 at a meeting at which a
30 quorum was present with a vote of 1,605.0 for; -0- against;
31 119.0 not voting; and 01 absent, pursuant to the powers vested
32 in the Council by Section 4 of Article VIII of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham
Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary -Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
