17 1(a) or (b) of Article II of the Constitution of the
18 Tohono O'Odham Nation, and that their applications are
19 approved, as herein above indicated.

20 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate
21 officers of the Tohono O'Odham Nation reduce this final
22 determination in writing regarding each of the foregoing
23 applications for enrollment in accordance with Section 3
24 (c) of Article III of the Enrollment Ordinance; give
25 notice of this Council's determination in accordance
26 with Section 4 of Article III of the Enrollment
27 Ordinance; and place the names of each applicant upon
28 the membership roll of the Tohono O'Odham Nation in
29 accordance with Article V of the Enrollment Ordinance.


30 The foregoing Resolution was passed by the Tohono O'Odham Council
31 on the 19th. day of September, 1989 at a meeting at which a
32 quorum was present with a vote of 1,607.5 for; -0- against;
116.5 not voting; and 01 absent, pursuant to the powers vested

1 in the Council by Section 1 of Article II and of Section 1 (h) of
2 Article VI of the Constitution of the Tohono O'Odham Nation,
3 adopted by the Tohono O'Odham Nation on January 18, 1986 and
4 approved by the Acting Deputy Assistant Secretary - Indian
5 Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
6 the Act of June 18, 1934 (48 Stat. 984).


