2	WHEREAS, the Tohono O'Odham Nation has negotiated a fair value
3	with the Bureau of Reclamation for the Central Arizona
4	Project right-of-way contained on portions of
5	tribal/district land within the exterior boundaries of
6	the San Xavier Reservation/District; and
7	WHEREAS, the Legislative Natural Resources Committee has
8	previously consented to approving and supporting San
9	Xavier District's request for similar fees stemming from
10	the El Paso Natural Gas Twin Buttes right-of-way; and
11	WHEREAS, there are currently no provisions within the Tohono
12	O'Odham Government system that specifically addresses
13	rights-of-way distributions; and
14	WHEREAS, the legal opinion provided by the Tohono O'Odhan
15	Nation's legal counsel indicated that the Nation's
16	current lease ordinance has no bearing on rights-of-
17	ways.
18	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation
19	hereby approves the disbursement of 100% of all proceeds
20	derived from the granting of an easement on San Xavier
21	District Tribal/District lands for the construction of
22	the CAP Reach 6/Black Mountain Pipeline.
23	BE IT FURTHER RESOLVED that this approval includes the sixty
24	percent (60%) increase in payment from Reclamation, and
25	all interest accrued from said payment, which total to
26	approximately \$163,800.00 .
27	BE IT FURTHER RESOLVED that the Bureau of Indian Affairs is
28	hereby directed to disburse the above referenced amount
29	to the San Xavier District upon receipt of payment from
30	Reclamation.
