

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Lease of Land to the San Xavier Cooperative, Inc.)

RES. NO. 315-89

1 WHEREAS, the San Xavier Cooperative, Inc. (Cooperative) intends
2 to consolidate all lands lying within the proposed
3 boundaries of the Cooperative farms; and

4 WHEREAS, there are two parcels of ground contained within the
5 proposed farm boundaries that are under the jurisdiction
6 of the Tohono O'odham Nation and are shown on Exhibit
7 "A" which is attached herein and made a part hereof; and

8 WHEREAS, the Cooperative wishes to lease the subject properties
9 on substantially the same terms and conditions as agreed
10 upon by the allottees; and


11 WHEREAS, the subject lease, LEASE SAN XAVIER COOPERATIVE ASSOCI-
12 ATION, INC. AND THE TOHONO O'ODHAM NATION is attached
13 hereto and made a part hereof.

14 NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative
15 Council, upon review of all pertinent documents relating
16 to the aforementioned lease, hereby supports the
17 Cooperative and San Xavier District requests to lease
18 approximately 41.1 +/- acres of Nation's lands to the
19 Cooperative.

20 BE IT FURTHER RESOLVED that the Chairman of the Nation is hereby
21 authorized to execute and approve all documents
22 effecting the attached lease for the benefit of the
23 Cooperative and the San Xavier District of the Tohono
24 O'odham Nation.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 20th day of September, 1989 at a meeting at which a quorum
27 was present with a vote of 1,724.0 for; 0 against; 0 not voting;
28 03 absent, pursuant to the powers vested in the Council by
29 Section 1(1)(j) of Article VI of the Constitution of the Tohono
30 O'odham Nation, adopted by the Tohono O'odham Nation on January
31 18, 1986, and approved by the Acting Deputy Assistant Secretary-
32 Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
