

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Intergovernmental Food Services Agreement  
Early Childhood Head Start/Home Start)

2 WHEREAS, the Child Care Food Program of the State of Arizona has  
3 funded breakfast, lunch and snacks for the Tohono  
4 O'Odham Early Childhood Head Start Program by means of  
5 an Intergovernmental Food Service Agreement between the  
6 Tohono O'Odham Nation and the State of Arizona; and

7 WHEREAS, the Tohono O'Odham Early Childhood Head Start Program  
8 has recommended renewal of said agreement, effective  
9 October 01, 1989 and support the Early Childhood Head  
10 Start Program continuance of the Child Care Food  
11 Program.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
13 Council that it does hereby approve the renewal of the  
14 application implementing the Child Care Food Program  
15 from October 01, 1989 through September 30, 1990.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
17 that the Tohono O'odham Nation's Officials, to wit: the  
18 Chairman, Vice Chairman and any designated official are  
19 hereby authorized to negotiate and execute the grant,  
20 provided, however, that any amendments affecting the  
21 funding or funding levels of this grant shall be  
22 submitted for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 20th. day of September, 1989 at a meeting at which a  
25 quorum was present with a vote of 1,724.0 for; -0- against;  
26 -0- not voting; and 03 absent, pursuant to the powers vested in  
27 the Council by Section 1 (f) of Article VI of the Constitution  
28 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
29 Nation on January 18, 1986, and approved by the Acting Deputy  
30 Assistant Secretary -Indian Affairs (Operations) on March 6,  
31 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
32 Stat. 984).
