1 WHEREAS, the District Council of Hickiwan District did on
2 September 16, 1989 approve their district budget in the
3 amount of Sixty Four Thousand Three Hundred Seventy
4 Seven Dollars (\$64,377.00); and


5 WHEREAS, the Hickiwan District Council has sufficient funds in

7 O'Odham Accounting Department to cover their proposed
8 budget; and

9 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
10 Hickiwan District budget which is attached and finds it
11 in order.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it hereby approves the Hickiwan District
14 budget as presented in the amount of Sixty Four Thousand
15 Three Hundred Seventy Seven Dollars (\$64,377.00) and
16 authorizes expenditures in accordance therewith.


17 The foregoing Resolution was passed by the Tohono O'odham

21 vested in the Council by Section 1 (d)(3) of Article VI of the
22 Constitution of the Tohono O'odham Nation, adopted by the Tohono
23 O'odham Nation on January 18, 1986, and approved by the Acting
24 Deputy Assistant Secretary -Indian Affairs (Operations) on March
25 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).



submittal.


