- WHEREAS, a request was made to schedule additional meetings to address pending budgetary and other matters; and
- WHEREAS, it was recommended that the issue of eye care be referred to the Health & Human Services Committee.
- NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative

 Council hereby refer the issue of eye care to the

 Legislative Health & Human Services Committee.
- BE IT FURTHER ORDERED that the Tohono O'odham Legislative Council hereby schedules the dates of September 27 and 28, 1989 for Special Council Meetings.
