6	the problem of using the salary/hourly scale which is
7	not adjusted to reflect cost-of-living increases and did
8	report that a revision of the salary/hourly scale needs

10	WHEREAS, the Budget and Finance Committee did recommend that for
11	fiscal year 1990 that salaries be based on current
12	salaries plus the five (5%) COLA increase and not the
13	steps outlined on the salary/hourly scale; and
14	WHEREAS, the Budget and Finance Committee does recommend to the
15	Legislative Council that a request be made to the
16	Executive Office that the salary/hourly scale be
17	reviewed and revised.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
19	Council that it hereby adopts the recommendations of the
20	Budget and Finance Committee that the 5% COLA be added
21	to current salaries and that the salary/hourly scale not
22	be used for fiscal year 1990 budgets.
23	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
24	that it hereby requests the Chairman of the Tohono
25	O'odham Nation to direct the Personnel Office staff to
26	review and revise the salary/hourly scale for review and
27	action by the Budget and Finance committee and the
28	Legislative Council.
29	BE IT FURTHER RESOLVED that this revision of the salary/hourly
30	scale be completed within six months so that the Natio
31	can have a current salary/hourly scale for its use.
