(Schuk Du;ag District - FY '90 Budget)

RES. NO. 328-89

1 WHEREAS, the Schuk Du;ag District Council on September 18, 1989  
2 did approve by District Resolution No. 9-18-89, the FY  
3 '90 Budget in the amount of \$184,504.38; and  
4 WHEREAS, the Schuk Du;ag District Council requests the  
5 Legislative Council to ratify the budget; and  
6 WHEREAS, the budgeted amount, upon ratification be allocated from  
7 the Tribal IIM Accounts to be expended in accordance  
8 with the attached budget.  
9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
10 Council that the Schuk Du;ag District budget for FY '90  
11 is hereby approved in the amount of \$184,504.38 .

12 The foregoing Resolution was passed by the Tohono O'odham Council  
13 on the 22nd. day of September, 1989 at a meeting at which a  
14 quorum was present with a vote of 1,724.0 for; -0- against;  
15 -0- not voting; and 05 absent, pursuant to the powers vested in  
16 the Council by Section 1 (d)(3) of Article VI of the  
17 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
18 O'odham Nation on January 18, 1986, and approved by the Acting  
19 Deputy Assistant Secretary -Indian Affairs (Operations) on March  
20 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
21 Stat. 984).




