

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Judicial Services FY '90 Budget Amendment)

RES. NO. 334-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Judicial Services Program under P.L. 93-638 contract
3 with the Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding or funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'Odham Legislative Council; and


7 WHEREAS, an amendment has been submitted for review and approval
8 by the Tohono O'Odham Judicial Services Program.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
10 Legislative Council does hereby approve the amendment to
11 the Judicial Services budget as attached.


12 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
13 that the Tohono O'Odham Nation's Officials, to wit: the
14 Chairman, Vice Chairman and any designated official are
15 hereby authorized to negotiate and execute the contract,
16 provided, however, that any amendments affecting the
17 funding or funding levels of this contract shall be
18 submitted for further prior approval by this Council.

20 The foregoing Resolution was passed by the Tohono O'Odham Council
21 on the 27th day of September, 1989 at a meeting at which a
22 quorum was present with a vote of 1,667.0 for; -0- against;
23 57.0 not voting; and 04 absent, pursuant to the powers vested
24 in the Council by Section 1 (f) of Article VI of the
25 Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986, and approved by the Acting
27 Deputy Assistant Secretary -Indian Affairs (Operations) on March
28 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).




