WHEREAS, the designated representatives of the Tohono O'Odham Nation have met with authorized representatives of Indian Health Services and developed a proposed Scope of Work and budget for the Program in the amount of \$269,524.00 for the period of October 01, 1989-September 30, 1990.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that on the basis of the proposed Scope of Work and Budget, it authorizes the designated representatives to complete contract negotiations for the Tohono O'Odham Psychological Services Program, and to include provisions for precontract costs, for resubmission to the Tohono O'Odham Legislative Council for final review and approval.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided, however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.
