

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Psychological Services)

RES. NO. 338-89

1 WHEREAS, the Tohono O'Odham Nation has operated the Tohono
2 O'Odham Psychological Services Program under a FY '88
3 P.L. 93-638 contract with the Public Health, Indian
4 Health Services; and

5 WHEREAS, the Tohono O'Odham Nation has continued to operate the
6 Tohono O'Odham Psychological Services Program throughout
7 FY '89; and

8 WHEREAS, the Tohono O'Odham Legislative Council has designated
9 three representatives of the Tohono O'Odham Nation as
10 its authorized representatives to enter into
11 negotiations with Indian Health Services for the Tohono
12 O'Odham Psychological Services Program for FY '90; and

13 WHEREAS, the designated representatives of the Tohono O'Odham
14 Nation have met with authorized representatives of
15 Indian Health Services and developed a proposed Scope of
16 Work and budget for the Program in the amount of
17 \$269,524.00 for the period of October 01, 1989-
18 September 30, 1990.


19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
20 Council that on the basis of the proposed Scope of Work
21 and Budget, it authorizes the designated representatives
22 to complete contract negotiations for the Tohono O'Odham
23 Psychological Services Program, and to include
24 provisions for precontract costs, for resubmission to
25 the Tohono O'Odham Legislative Council for final review
26 and approval.

27 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
28 that the Tohono O'Odham Nation's Officials, to wit: the
29 Chairman, Vice Chairman and any designated official are
30 hereby authorized to negotiate and execute the contract,
31 provided, however, that any amendments affecting the
32 funding or funding levels of this contract shall be
submitted for further prior approval by this Council.


1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 28th. day of September, 1989 at a meeting at which a
3 quorum was present with a vote of 1,610.0 for; 57.0 against;
4 57.0 not voting; and 02 absent, pursuant to the powers vested
5 in the Council by Section 1 (f) of Article VI of the
6 Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986, and approved by the Acting
8 Deputy Assistant Secretary -Indian Affairs (Operations) on March
9 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
10 Stat. 984).


