

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo Trading Post Lease)

RES. NO. 33-89

1 WHEREAS, a lease with Mr. and Mrs. Robinette concerning the
2 Pisinemo Trading Post expired on June 30, 1984, and the
3 Pisinemo District Council has negotiated a new lease for
4 a primary term of ten years, starting July 1, 1984, and
5 ending June 30, 1994, and for an additional renewal term
6 of ten years thereafter, ending June 30, 2004; and

7 WHEREAS, the new lease provides for minimum annual rental
8 payments, beginning July 1, 1988 through June 30, 1994,
9 of \$8,000.00 (which includes the payment of \$12,000.00
10 for back rentals for the period of July 1, 1984 through
11 June 30, 1988) payable to the Treasurer of the Nation in
12 monthly installments of \$666.67; and

13 WHEREAS, the Council approves of the new lease.

14 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council
15 approves of the attached lease with Travis and Cynthia
16 Lee Robinette for the Pisinemo Trading Post and
17 authorizes the Chairman of the Tohono O'Odham Nation to
18 execute it on behalf of the Nation.

19 BE IT FURTHER RESOLVED that the minimum annual rental payments of
20 \$8,000.00 paid thereunder to the Treasurer of the Nation
21 shall be deposited and credited in full to the account
22 of the Pisinemo District in accordance with the
23 provision of Ordinance No. 02-83.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 6th day of February, 1989 at a meeting at which a quorum
26 was present with a vote of 1,360.5 for; -0- against; 121.5 not
27 voting; and 158.0 absent, pursuant to the powers vested in the
28 Council by Section 1 (d) and (i) of Article VI of the
29 Constitution of the Tohono O'odham Nation, adopted by the Tohono
30 O'odham Nation on January 18, 1986, and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March
32 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
