1 WHEREAS, the Management of Health Services budget for FY '90 has
2 not been reviewed and approved for submittal to Indian
3 Health Services by the Tohono O'Odham Legislative
4 Council; and


5 WHEREAS, there is a need to continue services; and

6 WHEREAS, it will be necessary to utilize tribal funds to operate
7 the Management of Health Services Program until the FY
8 '90 budget has been awarded by Indian Health Services.


9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
10 Legislative Council does hereby authorize the use of
11 tribal funds to continue to operate the Management of
12 Health Services Program in accordance to the budget for
13 a period not to exceed 90 days.

14 The foregoing Resolution was passed by the Tohono O'odham Council
15 on the 28th day of September, 1989 at a meeting at which a
16 quorum was present with a vote of 1,670.5 for; 53.5 against;
17 -0- not voting; and 01 absent, pursuant to the powers vested in
18 the Council by Section 1 (d)(3) of Article VI of the
19 Constitution of the Tohono O'odham Nation, adopted by the Tohono
20 O'odham Nation on January 18, 1986, and approved by the Acting
21 Deputy Assistant Secretary -Indian Affairs (Operations) on March
22 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
23 Stat. 984).






