

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Indian Health Services AIDS Education
Budget Modification for FY 1988)

RES. NO. 343-89

1 WHEREAS, in Fiscal Year 1988, a proposal for AIDS Education was
2 submitted to Indian Health Service for \$20,000.00 with
3 Tohono O'Odham Legislative Council approval; and

4 WHEREAS, in December 1988, the Tohono O'Odham received an
5 allocation of \$10,783.00 of which \$663.20 was spent on a
6 TV and VCR for the showing of AIDS Education videos,
7 which left a balance of \$10,119.80; and

8 WHEREAS, the balance of \$10,119.80 must be spent before September
9 30, 1989; and


10 WHEREAS, a modification has been developed for the \$10,119.80 for
11 Office Supplies, Other Supplies and
12 Office/Communications which will meet the needs for AIDS
13 Education materials and for a computer, printer, and
14 computer accessories to input the Knowledge, Attitude
15 and Behavior (KAB) questionnaires for analysis status of
16 the AIDS Educational Program for changes as determined.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
18 Legislative Council has reviewed and approves the Indian
19 Health Service AIDS Education budget modification for
20 Fiscal Year 1988.


21 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
22 that the Tohono O'odham Nation's Officials, to wit: the
23 Chairman, Vice Chairman and any designated official are
24 hereby authorized to negotiate and execute the proposal,
25 provided, however, that any amendments affecting the
26 funding or funding levels of this proposal shall be
27 submitted for further prior approval by this Council.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 28th. day of September, 1989 at a meeting at which a
31 quorum was present with a vote of 1,667.0 for; 57.0 against;
32 -0- not voting; and -0- absent, pursuant to the powers vested
in the Council by Section 1 (f) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono
O'odham Nation on January, 18, 1986, and approved by the Acting
Deputy Assistant Secretary -Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).




