	Education materials and for a computer, printer, and
	computer accessories to input the Knowledge, Attitude
	and Behavior (KAB) questionnaires for analysis status of
	the AIDS Educational Program for changes as determined.

	Legislative Council has reviewed and approves the Indian

	funding or funding levels of this proposal shall be
	submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 28th. day of September, 1989 at a meeting at which a quorum was present with a vote of 1,667.0 for; 57.0 against; -0- not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
