(Table Action on Reconsideration of Distribution regarding
the El Paso Ajo Right-of-Way)

2 WHEREAS, on January 6, 1989, the Tohono O'odham Legislative
3 Council approved Resolution No. 09-89, "Approving
4 Renegotiated Fair Market Value Consideration for El Paso
5 Ajo Rights-of-Way;" and

6 WHEREAS, the distribution of the renegotiated fair market value
7 of the Easement of Rights-of-Way of \$95,000 was divided
8 as follows:

- 9 1. One-half or \$47,500 to the Tohono O'odham Nation
10 2. the balance, or \$47,500 to be divided as follows:
11 a) 59% or \$28,120.00 to the Sif Oidak District,
12 b) 40.8% or \$19,380 to the Hickiwan District; and

13 WHEREAS, the Nation has no adopted guidelines addressing the
14 distribution of proceeds for rights-of-way; and

15 WHEREAS, the Sif Oidak District respectfully requests that
16 Council reconsider the action approved in Resolution No.
17 09-89, "Approving Renegotiated Fair Market Value
18 Consideration of El Paso Ajo Rights-of-Way" regarding
19 the distribution of proceeds.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legisla-
21 tive Council hereby table the draft Council resolution
22 titled, "Approving the Reconsideration of Distribution
23 regarding the El Paso Ajo Right-of-Way."

24 BE IT FURTHER RESOLVED that this issue be referred to the Natural
25 Resources Committee for further investigation.

26 BE IT FURTHER RESOLVED that the tabling of this issue does not
27 effect the action approved in Resolution No. 09-89,
28 "Approving Renegotiated Fair Market Value Consideration
29 for El Paso Ajo Rights-of-Way."


30 The foregoing Order was DEFEATED by the Tohono O'odham Council on
31 the 6th day of February, 1989 at a meeting at which a quorum was
32 present with a vote of 581.5 for; 900.5 against; -0- not
voting; and 158.0 (6) absent, pursuant to the powers vested in
the Council by Section 1 (a) of Article VI of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham
