

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Third Year Funding for the Title VII
Bilingual Education Program)

2 WHEREAS, the Tohono O'Odham Nation is presently operating the
3 Tohono O'Odham Title VII Bilingual Education Program
4 under a three (3) year grant with the U.S. Department of
5 Education, Office of Bilingual Education and Minority
6 Languages Office; and

7 WHEREAS, the Tohono O'Odham Legislative Council is desirous to
8 continue to provide bilingual educational services to
9 the Tohono O'Odham Nation; and

10 WHEREAS, the Tohono O'Odham Title VII Bilingual Education Program
11 has submitted a budget for third year funding for review
12 and approval by the Tohono O'Odham Legislative Council.


13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it hereby approves the Tohono O'Odham Title
15 VII Bilingual Education Program for Third Year Funding.

16 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation will not
17 fund or operate the program in the interim while
18 negotiations are still being conducted and no executed
19 grant has been awarded by the U.S. Department of
20 Education, Office of Bilingual Education and Minority
21 Languages.


22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation's Officials, to wit: the
24 Chairman, Vice Chairman and any designated official are
25 hereby authorized to negotiate and execute the grant,
26 provided, however, that any amendments affecting the
27 funding or funding levels of this grant shall be
28 submitted for further prior approval by this Council.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 24th. day of October, 1989 at a meeting at which a
31 quorum was present with a vote of 1,452.0 for; -0- against;
32 106.0 not voting; and 166.0 absent, pursuant to the powers
vested in the Council by Section 1 (f) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono
O'odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary -Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).


