

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY '90 Tuberculosis Control Budget Modification)

RES. NO. 360-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Tuberculosis Control Program with a contract with the  
3 Arizona State Health Services Department; and

4 WHEREAS, any amendments affecting the funding or funding levels  
5 of the contract shall be submitted for review and  
6 approval by the Tohono O'Odham Legislative Council; and


7 WHEREAS, an amendment has been submitted by the Tohono O'Odham  
8 Nation's Tuberculosis Control Program for review and  
9 approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
11 Legislative Council does hereby approve the amendment to  
12 the Tuberculosis Control Program budget contract and  
13 authorize expenditures in accordance with the attached  
14 budget.

15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
16 that the Tohono O'odham Nation's Officials, to wit: the  
17 Chairman, Vice Chairman and any designated official are  
18 hereby authorized to negotiate and execute the contract,  
19 provided, however, that any amendments affecting the  
20 funding or funding levels of this contract shall be  
21 submitted for further prior approval by this Council.

22 The foregoing Resolution was passed by the Tohono O'odham Council  
23 on the 24th day of October, 1989 at a meeting at which a  
24 quorum was present with a vote of 1,558.0 for; -0- against;  
25 -0- not voting; and 166.0 absent, pursuant to the powers vested  
26 in the Council by Section 1 (f) of Article VI of the  
27 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
28 O'odham Nation on January 18, 1986, and approved by the Acting  
29 Deputy Assistant Secretary -Indian Affairs (Operations) on March  
30 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
31 Stat. 984).
