WHEREAS, the Enrollment Committee has determined that the following named person(s) were members of the Tohono O'Odham Nation on the date of the respective census rolls but that their name(s) had been inadvertently omitted therefrom, and had recommended that their name(s) be added to the rolls; and

WHEREAS, the Tohono O'Odham Council has reviewed the recommendations of the Enrollment Committee and approves thereof.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that, subject to the approval of the Secretary of the Interior, the names of the following person(s) be added to the official census rolls of the Sells, Gila Bend or San Xavier Reservation, to wit:

## 1472-SX-88 STOUT, Frances

BE IT FURTHER RESOLVED that the required approval be secured from the Secretary of the Interior before their name(s) be formally added to such rolls.

The foregoing resolution was passed by the Tohono O'odham Council on the 13th. day of November, 1988, at a meeting at which a quorum was present with a vote of 1,420.5 for; 189.5 against; 114.0 not voting; and 01 absent; pursuant to the powers vested in the Council by Section 1 (a) of Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
