

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling the Relinquishment of Selina A. Garcia)

RES. NO. 365-89

1 WHEREAS, the request for relinquishment of Selina Ann Garcia was
2 brought to the Tohono O'odham Legislative Council by the
3 Enrollment Committee (Committee); and

4 WHEREAS, it has determined through Committee testimony that the
5 relinquishment request was made by Selina Ann Garcia's
6 natural mother, a non-member of the Tohono O'odham
7 Nation without the consent of her natural father, a
8 Tohono O'odham member; and

9 WHEREAS, the Committee further testifies that Selina Ann Garcia
10 is a minor under the age of eighteen; and

11 WHEREAS, the Tohono O'odham Legislative Council does not wish to
12 infringe upon the rights of Selina Ann Garcia and her
13 natural father's right of consent.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
15 Council that the request for relinquishment of Selina
16 Ann Garcia by her natural mother is hereby tabled until
17 such time that the Tohono O'odham Legislative Council
18 are provided with proof that efforts were made to obtain
19 a statement of consent from Selina Ann Garcia's natural
20 father.

21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 13th day of November, 1989 at a meeting at which a quorum
23 was present with a vote of 1,557.0 for; 53.0 against; 114.0 not
24 voting; 01 absent, pursuant to the powers vested in the Council
25 by Section 1(a) of Article VI of the Constitution of the Tohono
26 O'odham Nation, adopted by the Tohono O'odham Nation on January
27 18, 1986, and approved by the Acting Deputy Assistant Secretary-
28 Indian Affairs (Operations) on March 6, 1986, pursuant to
29 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
