
1 WHEREAS, the following named person(s) have formally relinquished

4 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that  
5 it does hereby recognize that the above named person(s)  
6 have relinquished their membership in this Nation, and  
7 does hereby order that their name(s) be deleted from the  
8 membership roll.

10 The foregoing resolution was passed by the Tohono O'odham  
11 Council on the 13th. day of November, 1989 at a meeting at which  
12 a quorum was present with a vote of 1,289.0 for; 127.0 against;  
13 308.0 not voting; and 01 absent; pursuant to the powers vested in  
14 the Council by Section 3 of Article II and Article VI Section 1  
15 (h) of the Constitution of the Tohono O'odham Nation on January  
16 18, 1986, and approved by the Acting Deputy Assistant Secretary-  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to  
18 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
