2	WHEREAS,	the Bureau of Indian Affairs Law Enforcement personnel,
3		Marijuana Eradication and Reconnaissance Team
4		(M.E.R.T), have been detailed to the Tohono O'Odham
5		Reservation for eradication operations; and
6	WHEREAS,	the Tohono O'Odham Nation did not request nor authorize
7		the M.E.R.T operations on the Tohono O'Odham Nation; and
8	WHEREAS,	the Tohono O'Odham Nation's Police Department have not
9		executed a Memorandum of Agreement with the Bureau of
10		Indian Affairs Law Enforcement Agency, as it presently
11	÷	has with other Federal Agencies; and
12	WHEREAS,	the Bureau of Indian Affairs has not been responsive to
13		the Tohono O'odham Nation's request for information
14		regarding M.E.R.T operations on the Tohono O'Odham
15		Reservation; and
16	WHEREAS,	no mutual understanding exists; and
17	WHEREAS,	the Tohono O'odham Nation considers this action of the
18		Bureau of Indian Affairs Law Enforcement Agency to have
19		an adverse effect upon the Nation's sovereign powers,
20		jurisdictional authority, and also this situation will
21		have grave potential consequences upon the citizens of
22		the Tohono O'Odham Nation.
23	NOW, TH	EREFORE, BE IT RESOLVED that the Tohono O'Odham
		Legislative Council does hereby invoke the Removal and
24		Exclusion Ordinance, to remove the Marijuana Eradication
25		and Reconnaissance Team (M.E.R.T) from the Tohono
26		O'Odham Reservation.
