

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Robert Wood Johnson Foundation Grant for a Diabetes
Prevention Program)

RES. NO. 373-89

1 WHEREAS, the Tohono O'odham Nation has the highest recorded
2 prevalence rates of diabetes mellitus in the United
3 States, with prevalence above 50% in persons over age
4 40; and

5 WHEREAS, the Tohono O'odham Nation has established the elimi-
6 nation of diabetes mellitus as a health promotion and
7 disease prevention goal; and

8 WHEREAS, the Tohono O'odham Health Department (TOHD) in response
9 to this goal has initiated a Diabetes Prevention
10 Program; and

11 WHEREAS, the Robert Wood Johnson Foundation (RWJF) is sponsoring
12 grants for "Improving the Health of Native Americans"
13 which would support the conduct of this Diabetes
14 Prevention Program.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation
16 through the Tohono O'odham Health Department (TOHD) has
17 entered into a grant with the Robert Wood Johnson
18 Foundation for \$220,080.00 to conduct the Diabetes
19 Prevention Program.

20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
21 that it hereby approves the submittal by the Tohono
22 O'odham Health Department.

23 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
24 that the Tohono O'odham Nation's Officials, to wit: the
25 Chairman, Vice Chairman and any designated official are
26 hereby authorized to negotiate and execute the grant,
27 provided, however, that any amendments affecting the
28 funding or funding levels of this grant shall be
29 submitted for further prior approval by this Council.

30 The foregoing Resolution was passed by the Tohono O'odham Council
31 on the 20th day of November, 1989 at a meeting at which a quorum
32 was present with a vote of 1,550.5 for; 173.5 against; -0- not
voting; 05 absent, pursuant to the powers vested in the Council
by Section 1(f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January

18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
