LEGISLATIVE ORDER NO. 386-89

- WHEREAS, pursuant to Legislative Order No. 381-89, "Amending Council's Running Agenda December 1989 General Session" the following O'odham in Mexico items were included, specifically: 1) O'odham in Mexico Contract with George Barnett; 2) O'odham in Mexico FY '90 Budget Modification; and
- WHEREAS, concerns were expressed that the proposed contract and the Budget Modification had not received appropriate Committee reviews; and
- WHEREAS, major funding appropriations were requested for the attorney contract and budget for the O'odham in Mexico Program; and
- WHEREAS, the Domestic Affairs Committee contended that the contract and budget were to be considered critical in nature and required timely Council consideration.
- NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative

 Council that it hereby refers issues of the O'odham in

 Mexico budget and attorney contract to all appropriate

 Committees for a joint review on December 11, 1990.
- BE IT FURTHER ORDERED that any Committee concerned with the O'odham in Mexico issues attend the joint review.
- BE IT FURTHER ORDERED that the Tohono O'odham Legislative Council hereby establishes December 14, 1989 as a day for a Special Meeting to address the O'odham in Mexico attorney Contract and the O'odham in Mexico Budget.

The foregoing Legislative Order was passed by the Tohono O'odham Council on the 4th day of December, 1989 at a meeting at which a quorum was present with a vote of 1,046.0 for; 112.5 against; 565.5 not voting; 03 absent, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
