## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Title XX Grant - Child Day Care Budget Amendment)

RES. NO. 38-89

WHEREAS, the Tohono O'Odham Nation has consistently supported the nurturance of its young members by providing for their welfare through various programs and services designed to meet their special needs; and

WHEREAS, the Child Day Care Services Program has been successfully operated through the Early Childhood Division and has served many young Tohono O'Odham Children; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval. NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve this amendment to the grant and authorize expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grants or contracts, provided however, that any amendments affecting the funding or funding levels of the grants or contracts shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of February, 1989 at a meeting at which a quorum was present with a vote of 1,460.0 for; -0- against; 63.0 not voting; and 117.0 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
