2 approved, as herein above indicated.


3 BE IT FURTHER RESOLVED that the Chairman and other appropriate
4 officers of the Tohono O'Odham Nation reduce this final
5 determination in writing regarding each of the foregoing
6 applications for enrollment in accordance with Section 3
7 (c) of Article III of the Enrollment Ordinance; give
8 notice of this Council's determination in accordance
9 with Section 4 of Article III of the Enrollment
10 Ordinance; and place the names of each applicant upon
11 the membership roll of the Tohono O'Odham Nation in
12 accordance with Article V of the Enrollment Ordinance.

13 The foregoing Resolution was passed by the Tohono O'Odham Council
14 on the 6th day of December, 1989 at a meeting at which a quorum
15 was present with a vote of 1,557.5 for; -0- against; 166.5 not
16 voting; and 04 absent, pursuant to the powers vested in the
17 Council by Section 1 of Article II and of Section 1 (h) of
18 Article VI of the Constitution of the Tohono O'Odham Nation,
19 adopted by the Tohono O'Odham Nation on January 18, 1986 and
20 approved by the Acting Deputy Assistant Secretary - Indian
21 Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
22 the Act of June 18, 1934 (48 Stat. 984).
