4 994-H-80 QUINTERO, George Jr.


5 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that

13 a quorum was present with a vote of 1,585.5 for; 81.5 against;  
14 57.0 not voting; and 04 absent; pursuant to the powers vested in  
15 the Council by Section 3 of Article II and Article VI Section 1  
16 (h) of the Constitution of the Tohono O'odham Nation on January  
17 18, 1986, and approved by the Acting Deputy Assistant Secretary-  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to  
19 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
