	by the Tohono O'Odham Legislative Council's Judiciary
	Committee; and
WHEREAS,	the Judiciary Committee did review the supporting
	documents and recommended to the Tohono O'Odham
	Legislative Council that Ambrose J. Encinas be appointed
	to a six year term as a full-time Judge of the Tohono
	O'Odham Courts; and
WHEREAS,	the Tohono O'Odham Legislative Council finds it
	necessary to refer the applicants to the Districts for
	consultation and input, provided that this consultation
	shall not exceed thirty (30) days.
NOW, THE	REFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
	Council that the applicants, Mr. Ambrose J. Encinas and
	Mr. Larry Yazzie for vacant judgeship, be referred to
	the Districts to allow the Districts to have input on
	the selection of a permanent Judge, provided that the
	period of consultation shall not exceed thirty (30)
