

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Referring Issue of Judge's Appointment to the
Districts for their input)

2 WHEREAS, this Council is, by Section 4 of Article VIII of the
3 Constitution of the Tohono O'Odham Nation, charged with
4 the duty of appointing judges of the Tohono O'Odham
5 Courts; and

6 WHEREAS, there is a vacancy of one full-time judge's position;
7 and

8 WHEREAS, the judge's position was advertised for 30 days by
9 directives of the Judiciary Committee; and

10 WHEREAS, two people, Mr. Ambrose J. Encinas and Mr. Larry Yazzie,
11 did submit their applications and both were interviewed
12 by the Tohono O'Odham Legislative Council's Judiciary
13 Committee; and

14 WHEREAS, the Judiciary Committee did review the supporting
15 documents and recommended to the Tohono O'Odham
16 Legislative Council that Ambrose J. Encinas be appointed
17 to a six year term as a full-time Judge of the Tohono
18 O'Odham Courts; and

19 WHEREAS, the Tohono O'Odham Legislative Council finds it
20 necessary to refer the applicants to the Districts for
21 consultation and input, provided that this consultation
22 shall not exceed thirty (30) days.

23 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
24 Council that the applicants, Mr. Ambrose J. Encinas and
25 Mr. Larry Yazzie for vacant judgeship, be referred to
26 the Districts to allow the Districts to have input on
27 the selection of a permanent Judge, provided that the
28 period of consultation shall not exceed thirty (30)
29 days.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th day of December, 1989 at a meeting at which a quorum was present with a vote of 1,271.0 for; 180.0 against; 273.0 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
