

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing 5% COLA for Grants and Contracts
Program Budgets)

RES. NO. 39-89

1 WHEREAS, the Tohono O'odham Nation's Legislative Council did
2 review and pass FY '89 Tribal Budgets which included a
3 5% Cost of Living Allowance; and

4 WHEREAS, the FY '89 Grants and Contracts Program Budgets were
5 subject to change once a decision was made on the Cost
6 of Living Allowance.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
8 Council that it does authorize the Grants and Contracts
9 Program Budgets to be modified to include a 5% Cost of
10 Living Allowance for FY '89 effective October 01, 1988.

11 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
12 that the Tohono O'odham Nation's Officials, to wit: the
13 Chairman, Vice Chairman and any designated official are
14 hereby authorized to negotiate and execute the grants or
15 contracts, provided however, that any amendments
16 affecting the funding or funding levels of the grants or
17 contracts shall be submitted for further prior approval
18 by this Council.



20 The foregoing Resolution was passed by the Tohono O'odham Council
21 on the 7th day of February, 1989 at a meeting at which a quorum
22 was present with a vote of 1,523.0 for; -0- against; -0- not
23 voting; and 117.0 absent, pursuant to the powers vested in the
24 Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
