WHEREAS, the Tohono O'odham Nation's Legislative Council did review and pass FY '89 Tribal Budgets which included a 5% Cost of Living Allowance; and

WHEREAS, the FY '89 Grants and Contracts Program Budgets were subject to change once a decision was made on the Cost of Living Allowance.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

Council that it does authorize the Grants and Contracts

Program Budgets to be modified to include a 5% Cost of

Living Allowance for FY '89 effective October 01, 1988.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grants or contracts, provided however, that any amendments affecting the funding or funding levels of the grants or contracts shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of February, 1989 at a meeting at which a quorum was present with a vote of 1,523.0 for; -0- against; -0- not voting; and 117.0 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
