(Approving the Extension Request for Deferred Payment
on the Sif Oidak District Egg Production Project)

2 WHEREAS, the Tohono O'Odham Legislative Council has supported the
3 development of the Sif Oidak District Egg Production
4 Project; and

5 WHEREAS, the Tohono O'Odham Legislative Council is aware of the
6 deferred payment on the Privilege Tax and TERO Fee on
7 the said project which was passed per Resolution No.
8 25-89; and


9 WHEREAS, it is also aware that the project has not been completed
10 up to date, which would enable the District and/or the
11 Sif Oidak Development Authority to properly meet the
12 deadline of January 1, 1990.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it does hereby approve the request to
15 further defer the payment of the Privilege Tax and TERO
16 Fee for the Sif Oidak District Egg Project.

17 BE IT FURTHER RESOLVED that the payment is deferred to June 30,
18 1990, the first payment is due and payable on July 01,
19 1990 and thereafter on a quarterly basis.

20 The foregoing Resolution was passed by the Tohono O'odham Council
21 on the 28th. day of December, 1989 at a meeting at which a
22 quorum was present with a vote of 1,724.0 for; -0- against;
23 -0- not voting; and 02 absent, pursuant to the powers vested in
24 the Council by Section 1 (d)(4) of Article VI of the
25 Constitution of the Tohono O'odham Nation, adopted by the Tohono
26 O'odham Nation on January 18, 1986, and approved by the Acting
27 Deputy Assistant Secretary -Indian Affairs (Operations) on March
28 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
