2 did approve by Resolution No. 150-89 Budget Modification
3 No. 3 to do Archaeological Mitigation for the Schuk Toak
4 New Development; and


5 WHEREAS, the Water Project Office does submit Budget Modification
6 No. 4 to transfer funds to appropriate line items within
7 the budget for review and approval.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
9 Legislative Council has reviewed and hereby approves the
10 attached modification and authorizes expenditures in
11 accordance with the attached budget modification.

12 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
13 that the Tohono O'odham Nation's Officials, to wit: the
14 Chairman, Vice Chairman and any designated official are
15 hereby authorized to negotiate and execute the contract,
16 provided, however, that any amendments affecting the
17 funding or funding levels of this contract shall be
18 submitted for further prior approval by this Council.

19 The foregoing Resolution was passed by the Tohono O'odham Council
20 on the 28th. day of December, 1989 at a meeting at which a
21 quorum was present with a vote of 1,610.0 for; -0- against;
22 114.0 not voting; and 02 absent, pursuant to the powers vested
23 in the Council by Section 1 (f) of Article VI of the
24 Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986, and approved by the Acting
26 Deputy Assistant Secretary -Indian Affairs (Operations) on March
27 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
