The foregoing Resolution was passed by the Tohono O'odham Council on the <u>28th.</u> day of <u>December</u>, <u>1989</u> at a meeting at which a quorum was present with a vote of <u>1,610.0</u> for; <u>-0-</u> against; <u>114.0</u> not voting; and <u>02</u> absent, pursuant to the powers vested in the Council by Section <u>1</u> (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
