1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Schuk Toak/San Xavier Pre-Design/Design under a P. L.
3 93-638 contract with the Bureau of Reclamation; and

4 WHEREAS, any amendments affecting the funding or funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'Odham Legislative Council; and


7 WHEREAS, an amendment has been submitted by the Tohono O'Odham
8 Nation's Central Arizona Water Project for review and
9 approval to cover for FY '90 Administrative Costs.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
11 Legislative Council does hereby approve the amendment to
12 the Schuk Toak/San Xavier Pre-Design/Design contract.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
14 that the Tohono O'odham Nation's Officials, to wit: the
15 Chairman, Vice Chairman and any designated official are
16 hereby authorized to negotiate and execute the contract,
17 provided, however, that any amendments affecting the
18 funding or funding levels of this contract shall be
19 submitted for further prior approval by this Council.



25 57.0 not voting; and 02 absent, pursuant to the powers vested
26 in the Council by Section 1 (f) of Article VI of the
27 Constitution of the Tohono O'odham Nation, adopted by the Tohono
28 O'odham Nation on January 18, 1986, and approved by the Acting
29 Deputy Assistant Secretary -Indian Affairs (Operations) on March
30 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).




