

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Water Distribution Contract No. 7-CS-30-05900  
Budget Modification #11)

RES. NO. 402-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Water Distribution Program under a P. L. 93-638 contract  
3 with the Bureau of Reclamation; and

4 WHEREAS, any amendments affecting the funding and funding levels  
5 of the contract shall be submitted for review and  
6 approval by the Tohono O'Odham Legislative Council; and

7 WHEREAS, an amendment has been submitted by the Tohono O'Odham  
8 Nation's Central Arizona Water Project for review and  
9 approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
11 Legislative Council does hereby approve the amendment to  
12 the Water Distribution Contract.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
14 that the Tohono O'odham Nation's Officials, to wit: the  
15 Chairman, Vice Chairman and any designated official are  
16 hereby authorized to negotiate and execute the contract,  
17 provided, however, that any amendments affecting the  
18 funding or funding levels of this contract shall be  
19 submitted for further prior approval by this Council.

21 The foregoing Resolution was passed by the Tohono O'odham Council  
22 on the 28th. day of December, 1989 at a meeting at which a  
23 quorum was present with a vote of 1,618.0 for; -0- against;  
24 -0- not voting; and 106.0 absent, pursuant to the powers vested  
25 in the Council by Section 1 (f) of Article VI of the  
26 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
27 O'odham Nation on January 18, 1986, and approved by the Acting  
28 Deputy Assistant Secretary -Indian Affairs (Operations) on March  
29 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
