2 WHEREAS, the Tohono O'Odham Nation is presently operating the San  
3 Xavier Cooperative Farm Rehabilitation Pre-Design under  
4 a P. L. 93-638 contract with the Bureau of Reclamation;  
5 and

6 WHEREAS, any amendments affecting the funding or funding levels  
7 of the contract shall be submitted for review and  
8 approval by the Tohono O'Odham Legislative Council; and

9 WHEREAS, an amendment has been submitted by the Tohono O'Odham  
10 Nation's Central Arizona Water Project for review and  
11 approval.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
13 Legislative Council does hereby approve the amendment to  
14 the San Xavier Cooperative Farm Rehabilitation  
15 Pre-Design contract.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
17 that the Tohono O'odham Nation's Officials, to wit: the  
18 Chairman, Vice Chairman and any designated official are  
19 hereby authorized to negotiate and execute the contract,  
20 provided, however, that any amendments affecting the  
21 funding or funding levels of this contract shall be  
22 submitted for further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 28th. day of December, 1989 at a meeting at which a  
25 quorum was present with a vote of 1,618.0 for; -0- against;  
26 106.0 not voting; and 04 absent, pursuant to the powers vested  
27 in the Council by Section 1 (f) of Article VI of the  
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
29 O'odham Nation on January 18, 1986, and approved by the Acting  
30 Deputy Assistant Secretary -Indian Affairs (Operations) on March  
31 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
32 Stat. 984).
