

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham FY '90 Credit and Finance Contract Extension)

RES. NO. 404-89

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Credit and Finance Program under a P.L. 93-638 contract
3 with the Bureau of Indian Affairs; and

4 WHEREAS, the Tohono O'odham Nation does desire to extend the
5 performance of the contract through September 30, 1990;
6 and

7 WHEREAS, the Tohono O'odham Legislative Council has reviewed and
8 approved the Credit and Finance contract extension.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
10 Council that it hereby authorizes and requests the
11 Bureau of Indian Affairs to extend Contract No.
12 CTH50805789 with the Tohono O'odham Nation.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
14 that the Tohono O'odham Nation will not fund or operate
15 the program in the interim while negotiations are still
16 being conducted and no executed contract has been
17 approved by the Bureau of Indian Affairs.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
19 that the Tohono O'odham Nation's Officials, to wit: The
20 Chairman, Vice Chairman and any designated official are
21 hereby authorized to negotiate and execute the contract,
22 provided, however, that any amendments affecting the
23 funding or funding levels of the contract shall be
24 submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 28th day of December, 1989 at a meeting at which a quorum
28 was present with a vote of 1,483.0 for; 57.0 against; 184.0 not
29 voting; 03 absent, pursuant to the powers vested in the Council
30 by Section 1(f) of Article VI of the Constitution of the Tohono
31 O'odham Nation, adopted by the Tohono O'odham Nation on January
32 18, 1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
