The foregoing Resolution was passed by the Tohono O'odham Council on the <u>28th</u> day of <u>December</u>, <u>1989</u> at a meeting at which a quorum was present with a vote of <u>1,550.5</u> for; <u>116.5</u> against; <u>57.0</u> not voting; <u>04</u> absent, pursuant to the powers vested in the Council by Section <u>1(f)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary-Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
