

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Community Health Services FY '89 Budget Modification)

RES. NO. 406-89

1 WHEREAS, upon a recommendation from the Executive Committee the
2 Budget and Finance committee, approved to modify the FY
3 '89 Management of Health Services budget to transfer
4 Indirect Costs which were earmarked for the Community
5 Health Services Program to the Community Health Services
6 budget to cover costs for transportation services; and

7 WHEREAS, any amendments affecting the funding or funding levels
8 of the contract shall be submitted for review and
9 approval by the Tohono O'odham Legislative Council; and


10 WHEREAS, the Community Health Services Program has submitted its
11 FY '89 budget Modification for review and approval.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that it hereby approves the attached budget
14 modification.

15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
16 that the Tohono O'odham Nation's Officials, to wit: The
17 Chairman, Vice Chairman and any designated official are
18 hereby authorized to negotiate and execute the contract,
19 provided, however, that any amendments affecting the
20 funding or funding levels of this contract shall be
21 submitted for further prior approval by this Council.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 28th day of December, 1989 at a meeting at which a quorum
24 was present with a vote of 1,550.5 for; 116.5 against; 57.0 not
25 voting; 04 absent, pursuant to the powers vested in the Council
26 by Section 1(f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
