

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Management of Health Services FY '90 Budget
Modification and Extension)

RES. NO. 407-89

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Management of Health Services Program under an extension
3 of the FY '89 P.L. 93-638 contract with the Public
4 Health Indian Health Services; and

5 WHEREAS, any amendments affecting the funding or funding levels
6 of the contract shall be submitted for review and
7 approval by the Tohono O'odham Legislative Council; and

8 WHEREAS, the Management of Health Services Program has submitted
9 its FY '90 Budget Modification for review and approval;
10 and

11 WHEREAS, the Tohono O'odham Nation does request an extension to
12 the existing contract with Indian Health Services from
13 January 01, 1990 through September 30, 1990; and

14 WHEREAS, the Tohono O'odham Nation does request that all indirect
15 dollars be transferred to each prospective contract as
16 allocated for the intent use of Indirect Cost.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it hereby approves the attached budget
19 modification.

20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
21 that the Tohono O'odham Nation's Officials, to wit: The
22 Chairman, Vice Chairman and any designated official are
23 hereby authorized to negotiate and execute the contract,
24 provided, however, that any amendments affecting the
25 funding or funding levels of this contract shall be
26 submitted for further prior approval by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 28th day of December, 1989 at a meeting at which a quorum
29 was present with a vote of 1,610.0 for; 57.0 against; 57.0 not
30 voting; 03 absent, pursuant to the powers vested in the Council
31 by Section 1(f) of Article VI of the Constitution of the Tohono
32 O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
