21	that the Tohono O'odham Nation's Officials, to wit: The
22	Chairman, Vice Chairman and any designated official are
23	hereby authorized to negotiate and execute the contract,
24	provided, however, that any amendments affecting the
25	funding or funding levels of this contract shall be
26	submitted for further prior approval by this Council.

28	was present with a vote of 1,610.0 for; 57.0 against; 57.0 not voting; 03 absent, pursuant to the powers vested in the Council
29	by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
30	18, 1986, and approved by the Acting Deputy Assistant Secretary- Indian Affairs (Operations) on March 6, 1986, pursuant to
31	Section 16 of the Act of June 18, 1934 (48 Stat. 984).
